4. How Long Will Your Personal Data Be Stored?

Your personal data will be stored for at least the period specified in the law or relevant regulations for data retention. If there is no specific period specified in the law or relevant regulations, your personal data will be stored for reasonable periods, limited to the purposes of processing and in proportion to those purposes, ensuring that it is relevant, adequate, and not excessive.

5. Your Rights Regarding Personal Data

Regarding your personal data, you have the following rights:

- To learn whether your personal data is being processed,
- To request information if your personal data has been processed,
- To learn the purpose of processing your personal data and whether they are used for the intended purposes,
- To know the third parties to whom your personal data has been transferred domestically or abroad.
- To request the correction of your incomplete or inaccurate personal data,
- To request the deletion or destruction of your personal data within the framework of the conditions provided in the KVKK legislation,
- If your incorrect or incomplete data is corrected, deleted, or destroyed upon your request, to have this action notified to the third parties to whom your personal data has been transferred,
- To object to the occurrence of a result against you arising solely from the analysis of your processed data through automated systems,

• To demand the compensation of damages if you suffer any damage due to the unlawful processing of your personal data.

6. How Can You Exercise Your Rights Regarding Your Personal Data?

You can exercise your rights regarding your personal data by using the Relevant Person Application Form;

- In person by visiting Tasigo Hotels with a valid identification document,
- By sending a signed and photocopy of your identification document to the address Dede Mahallesi Haktanır Sokak No: 4 Odunpazarı / Eskişehir,
- By sending an email to kvkkbasvuru@tasigo.com with a mobile signature or secure electronic signature,
- By using a registered electronic mail (KEP) address and a secure electronic signature or mobile signature and sending an email to polidayinsaat@hs01.kep.tr.

According to the Communique on the Procedures and Principles of Data Controller Applications, the Relevant Person must include the following information in the application: name, surname, if the application is in writing, signature, Turkish ID number (in the case of a foreign applicant, nationality, passport number, or any ID number if available), address of residence or workplace for notification, if any, the email address used for notification, phone number, and fax number, and the subject of the request.

The Relevant Person should clearly specify the requested matter related to the right they wish to exercise in their application. Additionally, all relevant information and documents regarding the application must be attached to the application.

The request must concern the Relevant Person's own data. If the request is made on behalf of someone else, the applicant must be specifically authorized and this authorization must be documented (power of attorney). Furthermore, the application must include the identification and address information and be accompanied by identity verification documents.

Requests made by unauthorized third parties on behalf of others will not be considered.

7. How Long Will Your Requests Regarding the Processing of Your Personal Data be Responded to?

Your requests regarding your personal data will be evaluated, and a response will be provided as soon as possible and within a maximum of 30 days from the date they reach Tasigo Hotels. If your request is accepted or rejected with reasons explained, our response will be sent to the address you provided in the application, primarily by mail or email, using the method of communication used for the request, if possible.
